Federal Student Aid Programs

Your 2017-2018 Free Application for Federal Student Aid (FAFSA) has been selected for a process called verification. Before awarding Federal Student aid we must confirm the information you and spouse (if married) reported on your FAFSA. To verify that you provided accurate information on your FAFSA, we will compare it with the information on this worksheet and any other required documents. Additional documentation may be required if information provided for the verification process does not match information reported on your FAFSA. If it is determined that information on your FAFSA was reported incorrectly, our office must electronically correct your FAFSA before awarding.

IMPORTANT: Required Documentation

1. Complete and sign this Verification Worksheet
2. Review the letter from the Financial Aid Office for the complete list of required documents
3. Submit required documents to Southeast Tech's Financial Aid Office

Southeast Tech must review the required information, under Federal financial aid program rules (CFR Title 34, Part 668).

Failure to complete verification will delay your financial aid award.
